## IMPORTATION OF FRESH MANGO FRUITS FROM INDIA INTO MALAYSIA

The Department of Agriculture, Malaysia presents its highest compliments to the Department of Agriculture, Cooperation and Farmers Welfare, India.

- 2. I would like to thank your kind office for the invitation to study the system put in place for export of mango from India into Malaysia by mango fruit exporters. However, I am regret to inform you that the Department of Agriculture is not in the position to visit India for the mango season of 2018 due to limited resources and short notice from your kind office.
- 3. For the 2018 mango season, I am delighted to inform you that the Department of Agriculture will continue allowing importation of mango from mango seed weevil free area from the states of Gujarat, Maharastra and Uttar Pradesh. However, these mangoes also subjected to irradiation treatment at 400 gray. Detail information on import requirements will be communicated through import permit. I am sincerely hope that your kind office could provide us the details of the approved treatment providers in advance to facilitate the mango importation
- 4. The Department of Agriculture, Malaysia really hope that all issue pertaining to phytosanitary could be solved through consultative manner without any negative impact to the trade of both countries. I really hope that we could further strengthen and expand cooperation in plant biosecurity between Malaysia and India.
