The rates below apply to all audit types, including extensions, announced, unannounced, blended and remote. They will be applied to audits conducted from 01 August 2025.

NOTES

* Multiple audits:

When a site is audited against two or more BRCGS core Standards at the same time, the service package fee for the additional core Standard will be reduced to 470 GBP. For example, if a delivery partner audits to both Food Safety and Storage and Distribution standards, then the service package fee would be 935 GBP + 470 GBP = 1,405 GBP from 01 August 2025.

** Gluten-Free and Ethical Trading and Responsible Sourcing:

Customers who are audited against a BRCGS core Standard and want to add Gluten-Free or Ethical Trade and Responsible Sourcing, then the prices set out above apply (i.e. there is no further reduction in price as this is built into the service fee).

For Gluten-Free certification, other fees are applicable, payable by the site to BRCGS directly.

*** Plant-Based options:

The service fee for the Plant-Based Standard will be reduced to 470 GBP when:

- A site is audited against the Food Safety Standard and the Plant-Based Standard at the same time (combined audit).
- When the Plant-Based Standard is audited following the Food Safety Standard audit, but within the Food Safety Standard Certification Cycle.

The service fee would therefore be 935 GBP + 470 GBP from 01 August 2025.
