After thorough consultation with Stakeholders, Certification Bodies and Ministry of Textiles, APEDA has developed draft standards for introduction of end-to -end traceability system along with the entire value chain of organic textiles processing and handling.

National Accreditation Body in its 35th meeting held on 23/12/2019 has approved and advised launching of end-to-end traceability system for organic textiles along with the entire value chain of organic textiles processing and handling.

The Traceability system is being launched on voluntary basis for limited period of time with effect from 1st March, 2020. All Certification Bodies are hereby advised to give it wide publicity. Certification Bodies interested in getting extension of their scope of accreditation for organic textile traceability may apply to APEDA in the prescribed form along with policy procedures, checklist and formats. A copy of the form is enclosed. The Certification Bodies may submit their application for extension of scope accreditation for organic textiles latest by 28.02.2020 in order to consider their case by APEDA at the earliest.
