REQUIREMENT OF INSPECTORS FOR MANGO EXPORT TO SOUTH KOREA AND JAPAN FOR MANGO SEASON 2023

Dear Exporters,

As the Mango season 2023 is approaching, all stakeholders are informed that for export of mangoes to Republic of Korea and Japan, the sourcing produce is permitted only from registered farms.

Under the HortiNet system APEDA has already implemented MangoNet wherein farmers can register themselves through State Horticulture/Agriculture Department. The farmer's registration portal is open for the registration purpose.

The composite list of farmers who will supply mangoes will be extracted from the APEDA's HortiNet system (MangoNet) and would be sent to respective countries. As per the requirement, the export of mangoes would be allowed from the registered farmers for the respective countries under HortiNet system only.

It may be noted that the pack house for Mangoes export to Japan and South Korea have also be registered in accordance with pack house recognition scheme of APEDA and NPPO and compliance requirement as suggested by importing countries.

In this regard, exporters are suggested to provide business plan to export mangoes latest by 30th January, 2023 as per Annexure I enclosed to enable us to finalize the requirement for stationing of quarantine inspector from Japan and South Korea. It may be noted that the quarantine inspector would be invited based on the requirements to be received from the exporters.
