LEADERSHIP DEVELOPMENT FOR AN INTEGRATED FOOD SAFETY SYSTEM

The IFPTI Fellowship Program is a unique, year-long program for food protection professionals who want to make a positive impact on the profession through association membership, advocacy, and applied leadership.

This Program takes a multifaceted approach incorporating three on-location week-long sessions, periodic webinars, and a mentor-guided research project. This program is guided by recognized leaders in food protection and focuses on the areas of Professional Skills, Program Management, and Applied Leadership.

The Fellowship has over 75 alumni from federal, state, and local regulatory food protection agencies.

WHY IT'S UNIQUE

- Fellows are paired with a food protection mentor, who provides Fellows with one-onone advice and assistance related to the Fellows' research projects and who helps them develop professional growth plans that can lead to long-term career growth and leadership enhancement.
- A guided research project, presentation, and publication are completed by each Fellow over the year-long course. Fellowship Program original research project findings are published in a special edition of the Association of Food and Drug Officials (AFDO) Journal and presented at the AFDO Annual Educational Conference.

- Networking one-on-one with current and future federal, state, and local food protection leaders.
- The Fellowship Program is offered at no cost for selected U.S. participants. U.S. Fellows are reimbursed for all appropriate program travel expenses according to IFPTI's travel policy.
- Fellows receive 16.6 IACET CEUs upon completion of the program.

Fellows who complete the IFPTI Fellowship program represent the next generation of leaders ready to meet new challenges in a climate of dynamic and continuous change. The following statistics offer some key insights into the program's immediate and lasting value to the Fellows:

- 79% indicated receiving a promotion or being given more responsibilities within their regulatory agency, department, or division.
- 82% have delivered presentations at professional conferences or workshops.
- 80% have become more active in professional associations or work committees, with many assuming an increased leadership role.

CAREER-SPANNING COMPETENCIES

The Competency and Curriculum Frameworks together—known as the National Curriculum Standard—help food regulatory professionals plan their career and receive the necessary

learning experiences as their jobs evolve, with access to training, courses, mentoring and more. Regulatory agencies can also use the National Curriculum Standard to create career improvement paths for their employees.

Some content areas of the framework, such as Communication Skills and Emergency Response, span all career levels for food protection professions—whether for entry, advanced, technical specialist or leadership levels.

COMPETENCY-BASED LEARNING SYSTEM

Competency-based learning systems focus on front-end analysis to determine the desired knowledge, skills, abilities, and behaviors necessary for high-level job performance. Such systems emphasize the use of assessments to determine the level of competence against desired outcomes, and focus learning and developmental efforts on helping the individual determine a learning path, identifying the learning experiences that help the individual attain the desired competencies. The instructional design methodology known as ADDIE (analysis, design, development, implementation, and evaluation), coupled with stakeholder input, learning experience review, and support systems make the system robust, efficient, and effective.
